The following plans and information must be attached to the application for consideration:

1. A plan for adequate sanitation facilities and sewage disposal, approved by the Florida Department of Health and Rehabilitative Services;
2. A plan for parking facilities which may be located on site or off site; and, in addition, when the parking facilities are not located on site, a plan for the transportation of the patrons from said parking facilities to the event;
3. A plan for adequate medical facilities;
4. A plan for provision of adequate security and traffic control in and around the area;
5. A plan for illumination of the premises if the event is to occur or continue after dark;
6. A plan for fire protection;
7. A site plan, drawn to scale no less than 1 inch = 60 feet, showing the location and layout of all buildings and structures, parking facilities, sanitation facilities, medical facilities, security gates, ingress and egress points, and lighting poles;
8. Identification of how adjacent properties would be protected from the impacts of the event (noise, lighting, traffic, and related impacts);
9. Full disclosure, by promoters, of the financial backing of the event.

Below please find the information requested to complete the Special Events Permit Application:

1. Adequate Sanitation Plan:
 - a. Dewey O. Boster Sports Complex has a total of three bathroom stations providing sufficient sanitation facilities for the amount of people anticipated to attend.
2. Parking Facilities Plan:
 - a. Dewey O. Boster is able to accommodate the cars expected to be present
3. Medical Facilities:
 - a. The Deltona Fire rescue department will be present to assist with this area.
4. Security and Traffic Plan:
 - a. We will have paid security as we have in our previous events. Our security consists of retired police officers, in addition to this, we also have staff and volunteers who will also serve as security.
 - b. We will have two volunteers directing traffic at the entrance of the park with an additional three volunteers directing cars into parking spaces. Walkie Talkies will be available to facilitate communication between teams.
5. The Department of Parks and Recreation will provide lighting as needed for the event.

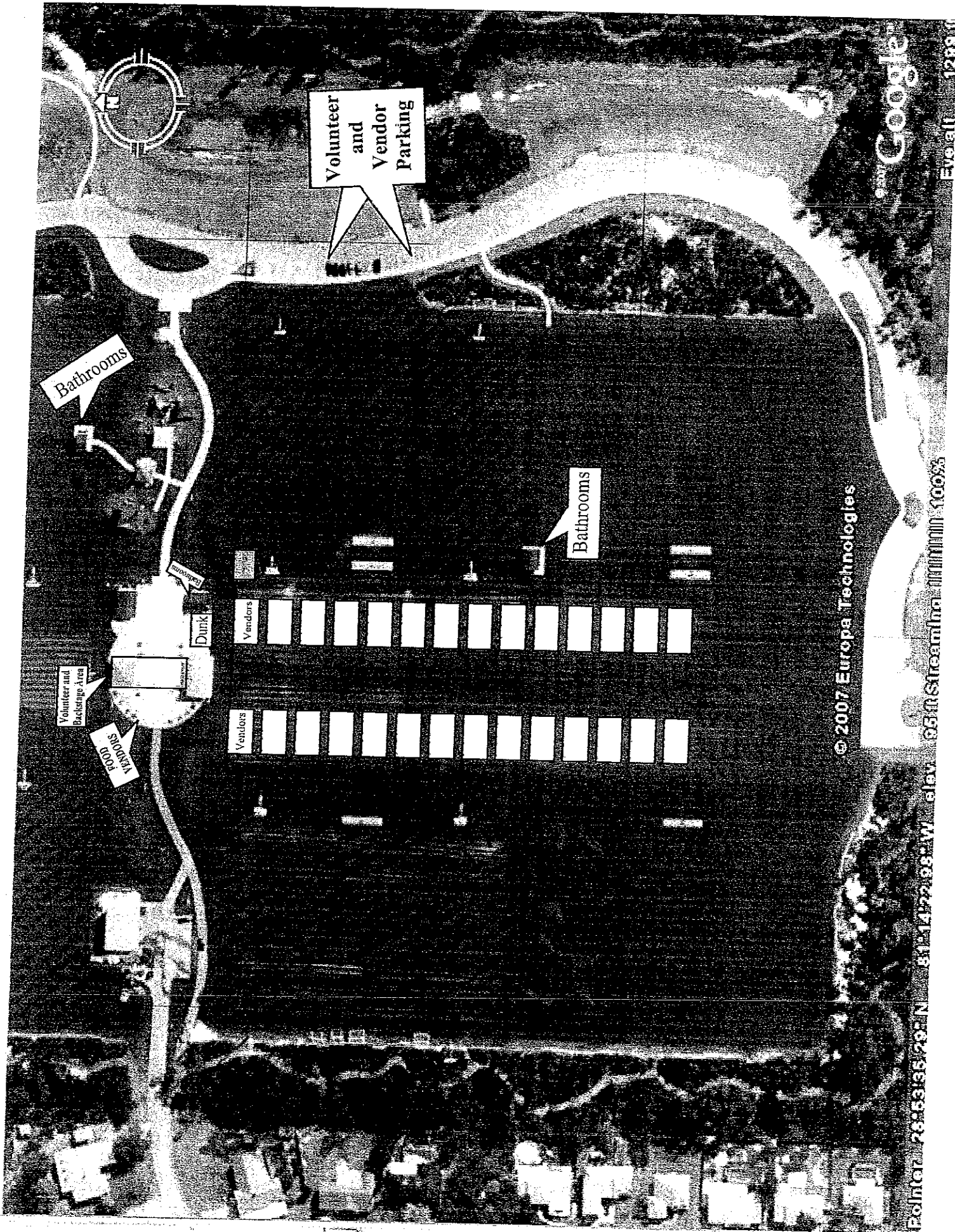

6. Fire Protection Plan
 - a. All Tents will be properly spaced and will meet applicable requirements for flammability.
 - b. Cooking concessions will meet applicable code requirements
 - c. Cooking fuels will be properly installed and protected.
7. Site Plan is attached.
8. We are confident that the effect on adjacent properties will be minimal as far as noise and lighting is concerned. We will have the Volusia County Sheriff's department available to direct traffic on Saxon Blvd. to minimize the effect on these properties.
9. Pizza Family Ministries, Inc. will conduct fund raising for the event. Any costs not covered by our fundraising efforts will be covered by Pizza Family Ministries, Inc.
