1 thinks the Commission needs a report from the Acting City Attorney as to whether these agreements
2 have been changed and what the changes are. Mr. Fowler stated he would have to review the changes
3 in the agreements and report back to the Commission.

4
5 Mr. Moore stated staff worked with the Legal Department to develop a template agreement so all the
6 agreements would be basically the same. The reason the agreements were grouped all together was
7 to manage staff's time more effectively and to know when the organizations came up for renewal.

8

17 additional five (5) years". Ms. Miller stated it is a one (1) year agreement with five (5) one (1) year
18 renewals. She stated there is a process the organization is required to go through in order to renew
19 the agreement such as an application form for each year to make sure the organization's insurance is
20 current, identifying the Board members, and indentifying the fields. She stated the agreements are
21 not automatically renewed and there is a default clause in the agreement if the City has any issues
22 with an organization a written notice would be provided to that organization stating the City does not
23 intend to renew its agreement with that organization.

24
25 Commissioner Denizac stated all the agreements need to come before the Commission every year
26 because Board members change and the financial situation of the City may change.

27
28 Mr. Moore explained the renewal process to include a renewal letter to the organization 60 to 90 days
29 in advance of the renewal date, a check of the organization's liability insurance, citizen's feedback,
30 background checks on coaches, and if an organization was not in compliance staff would conduct an
31 investigation.

24
25 Mayor Mulder asked each Commissioner to provide brief comments on their evaluations.

26
27 Ms. Miller stated she appreciated the Commissioners who were able to meet with her to go over
28 their review and she appreciated the comments and suggestions that were provided. She stated
29 should there be a favorable outcome with the overall evaluations she requested that there be no
30 discussion of a salary increase or benefit increase since her non-bargaining unit employees have
31 not received raises for two (2) years.

32
33 Commissioner McFall-Conte stated she gave Ms. Miller the middle of the road scores like threes
34 and fours, she did not score "supervision", she gave her a five (5) for providing regular
35 information and reports to the Commission and for physical management. She suggested Ms.
36 Miller meet one on one with citizens to work on a relationship with them, to work on anticipating
37 what is going to happen and to become more involved in service organizations.

38
39 Commissioner Denizac stated she met with Ms. Miller and discussed at length her strengths, areas
40 of concern, areas for improvement, areas of disappointment, add-on agenda items and concerns
41 from residents regarding the budget, the website and public record requests. She stated Ms. Miller
42 surrounds herself with good people to assist her, she utilizes the vast knowledge of staff and she
43 participates in community events. She stated areas for improvement are in professional judgment
44 and skills, attracting commercial development and reporting information to the Commission. She
45 suggested Ms. Miller take her role as City Manager seriously and that she only take direction from
46 the Commission as a whole. She stated she has great expectations that Ms. Miller will do great in
47 the future, she will improve at her role as City Manager and she suggested she give up the role as

1 City Clerk and have someone do the job as Acting City Clerk.

2
3 Mayor Mulder stated he had some of the same concerns as Commissioner McFall-Conte
4 regarding Ms. Miller working on anticipating what is going to happen and for her to be more
5 engaged in the community. He stated he appreciates all the time she spends on City events and
6 hopes she will continue to do so. He stated he would like her to be able to exercise her authority
7 as manager in a stronger way. He stated she relies a lot on her department heads which makes her
8 a good manager, she does not think she knows everything, she has an open mind and she is
9 growing into the job and is getting better at it all the time. He stated one of the things he enjoys
10 about her is when the Commission gives her clear direction he does not have to guess what is
11 going to happen or does not receive a hundred reasons why something could not be done. He
12 stated he would like to see continued effort for improved relationships with all the Commissioners.

13
14 Vice Mayor Carmolingo stated Ms. Miller has seen the good and the bad side of him and he
15 appreciates the relationship they have developed. He stated she has had some outside distractions
16 which have been solved, she has grown into her position, and he is satisfied with how she is
17 running things. He wished her good health in the coming year with her job.

18
19 Commissioner Deyette stated she felt Ms. Miller had done a terrific job and that it was an asset
20 that she had been the City Clerk and she knew the City inside and out. She stated she scored Ms.
21 Miller medium to high in several areas. She stated Ms. Miller is service oriented, never watches a
22 clock, has excellent skills for budgeting and managing City affairs, pays exceptional attention to
23 detail, reduced budget expenses and made excellent choices in directors and managers. She stated
24 the only criticism she has is that she be more firm with the Commission when there are times that
25 personnel must be let go or replaced regardless of how the Commission feels. She stated the
26 Commission should trust her to do a good job and she agreed that Ms. Miller should be more
27 visible at City events.

28
29 Commissioner Zischkau stated from time to time he has disagreed with decisions that Ms. Miller
30 had made, however, overall she has met his expectations in a very difficult environment.

31
32 **Motion by Commissioner Zischkau, seconded by Commissioner McFall-Conte to approve**
33 **the continued tenure of Faith Miller as City Manager until her next annual review and**
34 **accept her offer of an exception to her contract that her salary not be increased in the FY**
35 **09/10 and be the same salary as last fiscal year.**

36
37 **Motion carried with members voting as follows: Commissioner Denizac, For; Commissioner**
38 **Deyette, For; Commissioner McFall-Conte, For; Commissioner Zischkau, For; Vice Mayor**
39 **Carmolingo, For; and Mayor Mulder, For.**

40
41 **E. Discussion & direction re: garage sale signs and other signs in City right-of-ways.**

42
43 Mayor Mulder stated the Commission had directed staff to be more lenient with regards to garage
44 sale signs and it is causing unintentional consequences for enforcement reasons and both
45 Commissioner Denizac and Commissioner McFall-Conte agreed.

46
47 Commissioner Zischkau recommended the Ordinance go back to the Legal Department for further

1 review and get some further detailed discussion from Mr. Fowler as to how to clean up the
2 unconstitutional problem in Section 102-3, Subsection 24, which will resolve some of the other
3 issues the Commission has.

4
5 Mayor Mulder suggested enforcing the Ordinance regarding signs in the right-of-way as it was
6 previously done and he believes the only exception that is present under the current Ordinance is
7 with regards to City sponsored events.

8
9 **The Commission concurred to have staff enforce the Ordinance as it is written, the Legal**
10 **Department review the Ordinance regarding opinion signs and bring options back to the**
11 **Commission and to have a revised Ordinance at the next regular meeting if possible.**

12
13 **11. CITY COMMISSION COMMENTS:**
14

15 a) Commissioner Zischkau stated since the City is in a new budget year he would ask that the City
16 Manager get a running start on examining the big ticket items in the budget so the City does not
17 have the same problem next year of raising the tax rate 31% and instead of a list of small items
18 that do not really balance the budget which was presented in the workshop a month or two ago
19 that the Commission have a serious debate during the year as to what big ticket items can be taken
20 out of the budget for the coming fiscal year because the trend downward in property values could
21 and probably will continue for another year and anyone that is surprised next August that property
22 values are down and that the City is not going to get the same revenue at the same tax rate next
23 year has not been exercising good judgment and foresight.

24
25 b) Commissioner Deyette thanked the Volusia County Sheriff's Office (VCSO) and especially
26 Investigator Teague who did a presentation on gang awareness at her Neighborhood Watch
27 meeting. She recommended other Neighborhood Watch programs have the same presentation
28 and she encouraged other neighborhoods to form Neighborhood Watch programs because it helps
29 the VCSO to cut down on crime.

30
31 c) Commissioner Deyette thanked Mr. Moore, Mr. Manning and the entire Parks & Recreation
32 Department for doing a fantastic job last weekend at the River of Lakes Heritage Corridor Scenic
33 Highway ribbon cutting. She stated the City had two (2) tables which provided information on
34 the Thornby property, the All Inclusive Playground and the corridor where it comes through the
35 City. She stated the corridor is officially 120 miles of scenic highway designation which goes
36 from the Putnam County line through Seville, DeLand, Orange City, Debary, Deltona and
37 Osteen. She stated this is the City's opportunity to be in the media and she stated Bike Florida
38 will be coming through the corridor in October bringing hundreds of people.

39
40 d) Commissioner Deyette stated there is going to be an announcement that the Volusia Metropolitan
41 Planning Organization (MPO) won the Bicycle/Pedestrian Advisory Board (BPAB) of the Year
42 Award for the State and there is going to be a review and approval of a resolution amending the
43 FY 2009/2010 amendment to add repaving projects that utilize the American Recovery and
44 Reinvestment Act (ARRA) Funds.

45
46 e) Commissioner Denizac congratulated the Fire Department on a successful Safety Day on Sunday
47 which had a lot of participation.

- 1
2 f) Commissioner Denizac stated she wanted to make staff aware that she had called City Hall today
3 and the phones were out for approximately 30 minutes.
4
5 g) Commissioner Denizac reminded everyone that on October 17th will be the opening of the library
6 expansion and amphitheatre.
7
8 h) Commissioner Denizac congratulated the City Commission on a productive and smooth meeting.
9
10 i) Commissioner McFall-Conte stated she sent emails to the Commission inviting them to an event
11 the Boys & Girls Club is having on October 29th around 5:00 or 6:00 p.m. at Harris Saxon Park.
12 She stated there will be a gang awareness presentation for the members of the Boys & Girls Club
13 and the members of the Lake Helen Club who are being brought to Harris Saxon Park. She stated
14 she would like to see as many Commissioners and staff in attendance as possible.
15
16 j) Vice Mayor Carmolingo stated he hoped tonight would be the start of the Commission being able
17 to work together. He stated he felt good about what took place tonight, the support shown to the
18 City Manager and he hoped everyone would continue working together.
19
20 k) Vice Mayor Carmolingo stated he will be resigning from the Volusia Council of Governments
21 (VCOG) and Mayor Mulder will be taking over in his place. He stated he was in support of the
22 standing rule but, this Commission was not and that was not the reason he is resigning. He stated
23 the Water Authority of Volusia (WAV) is no more but, if it is okay with the Commission he
24 would like to continue being part of the League of Cities.
25
26 l) Vice Mayor Carmolingo thanked the employees for a job well done and he is happy with what is
27 happening in the City.
28
29 m) Vice Mayor Carmolingo stated a Healthcare Reform Session will take place on Thursday,
30 November 5th at 7:00 p.m. regarding the new health plan and doctors and experts will be
31 invited.
32
33 n) Mayor Mulder stated he would be happy to take Vice Mayor Carmolingo's place on VCOG
34 which is made up of mostly mayors and he would try to fill a really big pair of shoes.
35
36 o) Mayor Mulder stated the Boys & Girls Club event was the same night as his faith based
37 community meeting.
38
39 p) Mayor Mulder stated he sees a trend around the City and he was under the mistaken impression
40 that someone could not pull a trailer or hot dog cart behind a car, pull off on the side of the road
41 and sell items from the car. He stated it appears that a Health Department License, a City
42 Occupational License and written permission from the property owner is all that is needed. He
43 stated he encourages business but, he wants the kind of business ownership that assumes leases or
44 buys space and wants to make a permanent home in the City. He stated it is an appearance
45 standard issue and he thinks staff should look at how to regulate this issue.
46
47 q) Mayor Mulder thanked Mr. Moore and his staff for making the golf tournament happen which
48 was well attended. He stated he appreciated the City Manager coming out and driving around on
49 a golf cart. He stated he is a terrible golfer but, his team ended up six (6) under par with the help

1 of Mr. Moore and a golf pro from Winter Park. He stated it was a great event and he is looking
2 forward to the fishing tournament in November.
3

4 **12. CITY ATTORNEY COMMENTS:**
5

6 Mr. Fowler stated it is his impression that a corner has been turned in the Legal Department and he
7 thinks by the end of the month the turn would have been made and a lot of the things that may
8 have gotten away over the past few months will be back in line and it might actually be cheaper
9 for the City.
10

11 Commissioner Zischkau stated he was surprised that in the list of media where the City Attorney
12 position was being advertised that the Florida Bar was not included. Ms. Miller replied she
13 thought the Florida Bar was included and she would verify it.
14

15 **13. CITY MANAGER COMMENTS:**
16

17 Ms. Miller reminded the Commission of the Joint Meeting with the Economic Development
18 Advisory Board on Tuesday, October 13th.
