<p align="center"><b>NO. 1 CONSTITUTIONAL AMENDMENT ARTICLE I, SECTION 2</b></p> <p><b>Declaration of Rights</b></p> <p>Proposing an amendment to the State Constitution to delete provisions authorizing the Legislature to regulate or prohibit the ownership, inheritance, disposition, and possession of real property by aliens ineligible for citizenship.</p> <p><input type="radio"/> YES <input type="radio"/> NO</p>	<p><b>Assessment of Working Waterfront Property Based Upon Current Use</b></p> <p>Provides for assessment based upon use of land used predominantly for commercial fishing purposes; land used for vessel launches into waters that are navigable and accessible to the public; marinas and drystacks that are open to the public; and water-dependent marine manufacturing facilities, commercial fishing facilities, and marine vessel construction and repair facilities and their support activities, subject to conditions, limitations, and reasonable definitions specified by general law.</p> <p><input type="radio"/> YES <input type="radio"/> NO</p>	<p>Should education be a factor in choosing a City Manager and should the City Manager be given the additional duties of assisting the Commission with developing long term goals and strategies for the City, providing staff support for regional and intergovernmental cooperation and submitting reports to the Commission, and promoting partnerships among the Commission, staff and citizens in developing policy and building a sense of community?</p> <p><input type="radio"/> YES <input type="radio"/> NO</p>
<p align="center"><b>NO. 2 CONSTITUTIONAL AMENDMENT ARTICLE I, NEW SECTION</b></p> <p><b>Florida Marriage Protection Amendment</b></p> <p>This amendment protects marriage as the legal union of only one man and one woman as husband and wife and provides that no other legal union that is treated as marriage or the substantial equivalent thereof shall be valid or recognized.</p> <p>The direct financial impact this amendment will have on state and local government revenues and expenditures cannot be determined, but is expected to be minor.</p> <p><input type="radio"/> YES <input type="radio"/> NO</p>	<p align="center"><b>NO. 8 CONSTITUTIONAL AMENDMENT ARTICLE VII, SECTION 9</b></p> <p><b>Local Option Community College Funding</b></p> <p>Proposing an amendment to the State Constitution to require that the Legislature authorize counties to levy a local option sales tax to supplement community college funding; requiring voter approval to levy the tax; providing that approved taxes will sunset after 5 years and may be reauthorized by the voters.</p> <p><input type="radio"/> YES <input type="radio"/> NO</p>	<p align="center"><b>RESIDENCY REQUIREMENT FOR IN-HOUSE CITY ATTORNEY</b></p> <p>Should an in-house City Attorney be required to establish residency within the City and have full managerial authority over employees in the City Attorney's Office?</p> <p><input type="radio"/> YES <input type="radio"/> NO</p>
<p align="center"><b>NO. 3 CONSTITUTIONAL AMENDMENT ARTICLE VII, SECTIONS 3 AND 4 ARTICLE XII, NEW SECTION</b></p> <p><b>Changes and Improvements Not Affecting the Assessed Value of Residential Real Property</b></p> <p>Authorizes the Legislature, by general law, to prohibit consideration of changes or improvements to residential real property which increase resistance to wind damage and installation of renewable energy source devices as factors in assessing the property's value for ad valorem taxation purposes. <p align="center"><b>NO. 4 CONSTITUTIONAL AMENDMENT ARTICLE VII, SECTIONS 3 AND 4 ARTICLE XII, SECTION 28</b></p> <p><b>Property Tax Exemption of Perpetually Conserved Land; Classification and Assessment of Land Used for Conservation</b></p> <p>Requires Legislature to provide a property tax exemption for real property encumbered by perpetual conservation easements or other perpetual conservation protections, defined by general law. Requires Legislature to provide for classification and assessment of land used for conservation purposes, and not perpetually encumbered, solely on the basis of character or use. Subjects assessment benefit to conditions, limitations, and reasonable definitions established by general law.
